Thank you for your interest in applying for a scholarship to attend the **48th Annual FACAP Training Seminar** to be held March 4 – 6, 2026 at the World Equestrian Center in Ocala, Florida. The deadline for scholarship applications is January 23, 2026.

The scholarship is available only to those individuals employed in public fire service, law enforcement or criminal prosecution. FACAP has established scholarships that include the registration fee, all materials, meals, and housing.

If you are interested in attending the seminar and wish to apply for a scholarship, please print out and complete the attached scholarship application and submit it to the Fire Services and Law Enforcement Sub-Committee members as indicated below.

**Please select Scholarship #1 or #2, depending if you require housing. (Do not select #1 unless you intend to stay in FACAP provided housing.)**

Selection is based on a number of factors, such as present duties, number of other personnel attending from your department, attendance by scholarship at previous seminars, etc. On receipt of the application, the committee will immediately review and determine your eligibility. You will be promptly notified by electronic mail as to whether you have been approved for the scholarship. If at such time a waiting list develops, selection will be based on eligibility and date of application.

Once you have been approved, you will be provided with directions on how to register for the seminar on-line at [WWW.FACAP.ORG](http://WWW.FACAP.ORG). Those registering under the Scholarship will be given direction for purpose of waiving any registration fees.

Please do not apply for a scholarship unless you are certain of being able to attend and you have the approval of your supervisors. We have a limited number of scholarships available. If you are selected and do not attend, you could be preventing someone else from attending under a scholarship.
